Please note

1. If you are a UK taxpayer and you tick the gift aid box when you make a donation, HMRC will add an extra 25p for every pound you donate. You only have to do it once to make sure that all your future donations will be automatically topped up and we can also claim gift aid on any donations you have made in the past four years.
2. In order for the donations to qualify as Gift Aid, you must pay an amount of UK Income Tax at least equal to the tax we claim on your donations in the tax year.
3. If you are a higher rate tax payer [pay Income Tax at 40% or 45%], you can claim further tax relief in your Self-Assessment tax return. You can claim back the difference between the tax you've paid on the donation and what the charity got back when you fill in your SA tax return
4. You can cancel this declaration at any time by notifying the charity.
